AMENDING ALAMEDA MUNICIPAL CODE CHAPTER XXIV PUBLIC HEALTH TO ADD SECTION 24-14 PROHIBITION ON GASOLINE-POWERED LEAF BLOWERS

DIGEST

The ordinance amends the Alameda Municipal Code by adding Section 24-14. Gas-powered leaf blowers disperse air pollutants over a much smaller area, causing the operator, as well as surrounding inhabitants, to come into contact with the increased pollution. It is in the best interest of the City and its residents to preserve the quality of life in Alameda and to protect the public health, safety, and general welfare by banning all gasoline-powered leaf blowers and minimizing air pollution in the city. Deferring the effective date of this Ordinance until January 1, 2023 allows users significant lead time to plan for the phase out of gasoline-powered leaf blowers.

The ordinance was introduced at the Regular City Council Meeting of September 21, 2021, passed to print by 5 Ayes, 0 Noes, 0 Absent, 0 Abstentions(s). Consideration of final adoption is set for the Regular City Council Meeting to be held in the City Council Chambers, City Hall, corner of Santa Clara Avenue and Oak Street, Alameda, California, on October 5, 2021 at 7:00 p.m.
