PLN22-0367 - West Midway-RESHAP Development Plan Workshop.** The Historical Advisory Board will hold a public workshop to review and comment on the first draft of the Development Plan for the West Midway-RESHAP housing project at Alameda Point on the 38 acres generally located between Main Street, West Tower Avenue, West Midway Avenue, and Pan Am Way. The redevelopment of this site will require demolition of existing buildings. No final action on the environmental review or the Development Plan will occur at this meeting.
- 2. Building Electrification Ordinance Workshop.** The Historical Advisory Board will hold a public workshop to review and comment on draft ordinance to require all newly constructed buildings to be all-electric. The ordinance would also require full switching existing buildings from natural gas-powered appliances to electric-powered appliances when they are being substantially rehabilitated or expanded.
- 3. Update on the Draft Housing Element 2023-2031.** The Historical Advisory Board will be updated on the status on the Draft Housing Element and Draft Zoning Amendments to address State Fair Housing Law and to accommodate the Regional Housing Needs Allocation for the 2023-2031 planning period.
