#### CITY OF ALAMEDA - PUBLIC HEARING REGARDING HOUSING AND COMMUNITY DEVELOPMENT NEEDS

THE ALAMEDA CITY COUNCIL will hold a Public Hearing on January 3, 2023. The public is invited and encouraged to provide omments on the City's housing and community development needs for fiscal year (FY) 2023-24. This relates to activities that will be funded by Community Development Block Grant (CDBG) and approved in the FV 2023-24 Annual Action Plan. Based on past funding, the City expects to receive approximately \$1,150,000 in CDBG Entitlement funds and \$80,000 in Program Income for FY 2023-24. At least 70% of CDBG funds must benefit low- and moderate-income residents or neighborhoods; a limited amount of funds may be allocated to eliminate blight in selected areas

The development of an annual Action Plan is required by the Department of Housing and Urban Development (HUD) and will be submitted through the Alameda County HOME Consortium. The Annual Action Plan will identify the priority housing and community development needs. In the past, the Five-Year Consolidated Plan and annual Action Plan have prioritized: preserving and increasing affordable housing and supportive housing; reducing housing discrimination; preventing homelessness and addressing non-housing community development needs, such as neighborhood improvements, public services, accesements and economic development. 
