The ordinance implements Senate Bill 9, which amended Section 66452.6 of the Government Code and added Government Code Sections 65852.21 and 66411.7, changing the requirements for additional housing units on properties within a single-family zone and for parcel map approval of an urban lot split. SB 9 provides that a local agency may adopt an ordinance that requires ministerial approval for: (1) a proposed housing development containing no more than two residential units on a lot within a single-family residential zone, and (2) a parcel map for an urban lot split, both subject to certain conditions.
The ordinance was introduced at the Regular City Council Meeting of March 1, 2022, passed to print by 5 Ayes, 0 Noes, 0 Absent, 0 Abstention(s). Consideration of final adoption is set for the Regular City Council Meeting to be held in the City Council Chambers, City Hall, corner of Santa Clara Avenue and Oak Street, Alameda, California, on March 15, 2022 at 7:00 p.m.
