Yacht Club Gathers to Remember Peter Tangermann, 1942-2018

A gathering of friends, family and members of the local boating and newspaper communities came together last Sunday to remember local resident, Peter Tangermann, who passed away recently.

Tangermann, a native of Germany, immigrated to the U.S. in 1968. He spent about four decades in the newspaper delivery business, including running his own company. He was a live-aboard at Fortmann Marina for several years and a regular at the Alameda Yacht Club. Many anecdotes were shared about the gregarious fellow who could be relied on for a smile and a good laugh, led by his long-time companion Judy.

Sun staff remember Tangermann as a loyal, efficient and hardworking delivery logistician who studied Alameda in preparation for taking on delivery of the Alameda Sun in its very early years. He audited every street and house providing a detailed report on exactly how many



copies would be needed to cover the majority of homes in town. His steadfast work helped establish this newspaper.

Some might recall Tangermann's giant grey delivery truck nicknamed "The Bismarck" after the legendary

German battleship. The truck happily sported an "I Love Alameda" bumper sticker on its back door.

As he would have liked it, the many who gathered at the yacht club to remember him ate a lavish feast and drank toasts in his memory.

According to his last words, "the spirit is now free to go wherever it may like." He asked for no marker. The longtime boater asked instead that he be remembered whenever one looks out to sea.
