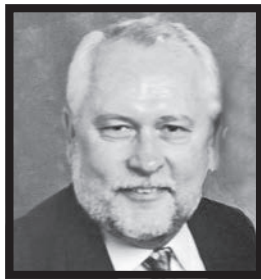


Local Deaths
