Only the City Council can determine the distribution and percentage of land that will be used for residential development, commercial space and public use. Councilmembers Jim Oddie and Frank Matarrese and Mayor Trish Spencer are all up for election next year. What they do regarding the development of Encinal Terminals is a litmus test for Alameda Citizens Taskforce (ACT) and many other residents.

ACT is committed to:  
■ Building the current number of approved affordable housing units at Encinal Terminals, about 80 — more, if possible.  
■ Maintaining the current four-

story, 60-foot, building-height limit and eliminating all the towers.

■ Addressing traffic problems and concerns with real mitigation plans, not the Traffic Demand Management (TDM) systems they've been using that haven't worked.

■ Limiting the size and scope of Encinal Terminals to a reasonable, practical number — a number that takes into account housing needs, safety and traffic congestion, open space, coastline access, Alameda's aesthetics and the reasonable capacity of the site as identified in the state-approved 2015-2023 housing element.
