1. **PLN19-0377 - Lot Line Adjustment - 1951 Harbor Bay Parkway - Applicant: Joe Ernst.** Consideration of a Lot Line Adjustment application to reconfigure three parcels in the Harbor Bay Business Park. The reconfiguration merges two vacant lots into one lot and includes transfer of land with a third, developed lot. Two lots will result from the lot line adjustment, including an 8.4-acre lot with existing development and a 5.1-acre vacant lot. The project site is located in the Harbor Bay Business Park C-M-PD (Commercial-Manufacturing Planned Development) Zoning District.
