DIGEST
The ordinance establishes regulations governing the zoning of commercial cultivation, manufacture, distribution, delivery, testing, and sale of cannabis and cannabis products. The purpose of these regulations is to provide requirements and criteria to approve zoning of cannabis businesses engaged in such uses.
