The VA is now ready to seek certification for its wetland mitigation plan. The VA's project will impact 10 acres of existing wetlands. However, the VA plans on replacing only seven of those acres on its property. It is proposing instead to purchase credits in a wetland mitigation bank for an already completed restoration

project in Redwood City for the remaining three acres.

The Sierra Club questioned the wetland credit scheme. "Purchasing credits in a mitigation bank is only warranted when on-site mitigation is either impossible, or would have poor quality or no quality due to poor chances for success," said La Force. "The area surrounding the Runway Wetland, where seven acres of wetland are

being proposed as mitigation for project impacts, can easily accommodate another three acres."

encumber Alameda with several million dollars in expense and have the property lay dormant for years?

2) Am I committed enough to helping the homeless to expose Alameda to the risk of an increase in our homeless population?

If both Measures get a major-

ity of the votes the measure with the most votes prevails. If both Measures fail to get a majority vote, Measure A, in effect, wins because it is a non-binding initiative to confirm a Dec. 18, 2018, City Council zoning ordinance amendment that allows for the wellness center. Measure A's loss would not repeal that amendment. However both measures losing could cause Council to reconsider its December decision.

These two measures have positive and negative consequences that all of us will be living with far into the future. Everybody needs to take the time to be well informed and to vote!
