 The ordinance repeals Article XIV of Chapter VI of the Municipal Code (which was suspended when Council adopted Ordinance No. 3148), Article XV of Chapter VI of the Municipal Code (which includes portions of Ordinance No. 3148 and Ordinance No. 3244) and Ordinance No. 3246 (uncodified), and, in its place, a restated Rent Control, Limitations on Evictions and Providing Relocation Payments Ordinance is adopted, which Ordinance would track many provisions of Ordinance No. 3148 but remove the ambiguities, internal inconsistencies and latent "loopholes" and would imbed in the restated Ordinance the ordinances City Council adopted earlier this year.
 The ordinances were introduced at the Regular City Council Meeting of September 3, 2019, passed to print by 4 Ayes, 0 Noes, 0 Absent, 1 Abstention.
